# From the President Sharon McNamara-Home

January 1<sup>st</sup> – a time for New Years' resolutions! What change can I make; what new direction can I go in? That's always a frustration for me since I know that I probably will give it up before long. Why? Because change is difficult; it takes energy and a positive attitude; it takes dealing with problems and not giving up; it takes being strong enough to look for a new path, a new way of doing something; it takes *staying* strong. Whew! I'm feeling my age!

I was talking with a friend at the Fall Conference and fussing about some of the difficulties that were getting the best of me at school. She gently stopped me and made me look at myself. 

# From the Editor's Desk Pat Deaville

The same can be said of LMEA. LMEA is evolving. It will stay the same in some ways. But it will evolve into a better whole. To older members, we have seen the process taking place over the years. Evolution rarely happens rapidly. Yet it is constant. For us senior members, it seems there is always something that is new or different.

To younger members, this evolution can happen somewhat undetected. Harder to see all that is different in the moment unless you have experienced the past.

But in truth, it is the vitality of our newer members that has been critical to LMEA's evolving in new and positive ways.

Some of our most recent changes are natural responses to *the evolving digital world* around us. Believe it or not, *LMEA's creation of a website* is a relatively new innovation for the organization. Yet in just a few short years, it is hard to imagine what we would do without it.

Even though it is just in its infancy, the *LMEA website is already in for an overhaul*. Those changes are well on their way into becoming a reality. The site has already become an important information and action site. But as our website has evolved, the demand for making it more versatile and comprehensive has grown.

While maintaining much of its current functionality, our website will also become a tool for professional development that will supplement what is provided at our annual music conference.

The Louisiana Musician began transitioning into a digital product shortly after the creation of the website. While there are no plans to eliminate the hard-copy magazine for the opening of school and conference, there is great potential in producing one or more expanded versions of the magazine as digital products in the spring semester.

Within the next few years, the magazine will be supplemented by *electronic newsletters* that will *periodically update members* on changes and developments throughout the school year while also providing *links to new and useful resources* that will be housed on our website, the NAfME website, and associated organization sites.

We will also be switching some electronic communication with members to programs such as "remind or messenger" rather than regular emails. We will also consider some *increase in the use of "Dropbox"* based on membership needs and requests.

Audition processes for all-state groups are evolving. For many years, all-state string auditions have been utilizing recordings rather than live auditions. Just this past fall all-state jazz ensemble auditions became all-digital with great success.

While no decisions have been made for the future, there will be much discussion on the continuing evolvement of all-state auditions towards a more digital approach.

Last but not least assessments (festivals) are changing. The addition of a *state solo assessment* to compliment district solo assessment has been a new development. It is a great opportunity for our students and music programs to elevate their level of performance and evaluation.

The switch from cassette tape to digital for adjudication comments is also a relatively new innovation that has grown in usefulness and popularity. How long before adjudications sheets themselves are prepared and transmitted digitally?

Louisiana has remained as perhaps the only state in the nation with a centralized "large ensemble state assessment" following a "district level assessment." Changes are on the horizon. Providing a "state level" assessment at various regional sites is already in the planning phases for the upcoming school year.

Stay tuned. The evolution is constant.

## Elementary Division Chairman Michele White

#### Reviewing the 2014 Conference and Planning Ahead for 2015

"I would rather instill in my amateur students love, than knowledge, of music. Left with only knowledge, they will at the end, close their books and consign the course to forgetfulness. However, if they have learned to love but the smallest part of the art, they are likely to pursue some phase of it the rest of their lives." - Ernst Bacon, composer



I remember Lamar Robertson, music educator extraordinaire, coming into my classroom when I first began teaching at R. W. Vincent Elementary School. When he walked in the room, I was nervous: we had had a week of rain and my kindergarten children needed some extra movement activities to make up for no outside recess that week, so I had decided to add "Skip to My Lou" to my plan. They copied my motions on the verse and skipped around during the refrain. The rule was they had to be back on the circle – in their spot – when I sang, "Skip to my Lou, my Darlin'"! If they didn't get back to their places, they were out. The kindergarteners were singing, moving, laughing, and enjoying our game. Lamar stood watching them; it wasn't something I had been taught to do in my Kodály training – it was a pure survival technique! When my students left, Lamar said two things that reinforced my belief that he is one of the greatest living teachers of all time, and that I was on the right track as a music teacher. "Michele, what a super way to teach ABA form to those youngsters!" and "You know, if the kids don't love coming to music, it doesn't matter what we teach. And, I can tell they love coming to music class." Lamar Robertson will be sharing his expertise with anyone who attends LAKE's Winter Workshop on January 31 in Sulphur, LA. His topic is "Using Orff Instruments in the Kodály Classroom". I'm sure Casey Doucet, LAKE's new president, will have additional information about LAKE's activities in this issue of Louisiana Musician.

Wow – what a great conference we had in November. If you missed it, I am very sorry – because it was a fantastic opportunity to learn lots of new material, gain new teaching strategies, and share with colleagues. However, there is plenty of time now to begin planning to attend this year's conference on November 19-21, 2015.

Some of the highlights of the 2014 conference included Denise Gagne's myriad sessions, Dr. Daniel Todd's thoughtful and useful reading sessions and ideas on teaching choral literature to upper elementary and middle school students, and Brandon Blaylock's "Bob Barker" session on how to channel Bob Barker in your music classroom.

In addition, Dr. Charlotte Mizener showed us how music is essential in teaching language literacy and how we can get to the core of English Language Arts literacy through our tasks in the music classroom. And, Dr. Sarah Bartolome gave us a mini-lesson on Cajun music, activities, and games. It was a superb conference!

There were some great suggestions and comments given to us by all of you through our annual elementary sessions evaluation form. I have submitted this report to the LMEA Board, and I am including some of these ideas now. - The connections made with Common Core, SLTs, Observations, and COMPASS were very helpful
- Explanations about what we can make for ourselves cheaply and how to apply them were extremely helpful
- · I loved the music literacy games session with Brandon Blaylock

#### Suggestions/Critiques - Conference Specific

- · Could we have an elementary luncheon on Friday (LAKE and Red Stick could co-sponsor or BYO lunch?
- Is it possible to have 75-minute sessions with a 15-minute break?
- Please include sessions that are more of an introduction to Kodály philosophy
- Could we have more presenters who are pre-k materials and upper elementary focus (4th/5th grades)?
- More booths for elementary teachers!

#### $Suggestions/Critiques-LMEA\ Specific$

- Please re-organize the LMEA website; it is not user-friendly
- · Have the conference schedule available much earlier
- Have a session on how to teach a "Fine Arts Survey" course
- We need more tips for working with grade 5 and up (especially boys)

# LMEA Advocacy Committee John Mlynczak

Dear LMEA Members,

As a music educator you are extremely valuable to your students, school and community. NAfME, the NAMM Foundation, and the SupportMusic Coalition are providing LMEA with support and advocacy resources in order for us to promote the positive benefits of music education.

Everything we do as educators is an Advocacy effort: What we teach, how we speak to parents, what we say at performances, and how we structure our evaluations. LMEA strives to support every music educator in Louisiana in delivering a consistent and positive message about the benefits of music education. We have two goals:



- 1. Every child in Louisiana has access to a high-quality music program from K-12, including weekly general music for all children K-5.
- 2. Every school in Louisiana has certified music educators whose sole duties and evaluations are focused on music education.

So where do we begin? Well, this is the same as teaching beginning band, choir, or orchestra. We start by making a sound, and work patiently and persistently over time to refine and focus our sound into beautiful music that everyone enjoys. Just as in music, our Advocacy efforts will never be complete. We will constantly strive for improvement, more collaborators, and more listeners. Here is what you can do to help us make a sound:

- 1. Teach your students how to share their enthusiasm in music. Have them sing to their parents, encourage them to perform outside of school, and continue to foster a passion for music.
- Speak to your school parents about the benefits of music and identify leaders in the community. Parents will be your best advocates, but we must foster their enthusiasm early.
- 3. Share your success with administration. Use your evaluations, Professional Growth Plans, and lesson plans as an opportunity to share the positive impacts of music education. Share your success stories through email, notes, or mention in passing.
- 4. Prepare your 30-second "elevator speech" on Advocacy. If you get your Principal's ear, end up in a grocery store checkout line with the PTO President, or run into a local or state legislator at the coffee shop, what would you say?
- Coordinate with parents and other music educators in your community to ensure that every school board meeting includes dialogue about the benefits of music education.


A nominee, living or deceased, active or retired, should be or should have been:

- 3. An active music educator or administrator in music education in a Louisiana school or institution of higher learning for a period of not less than twenty years.
- 4. An active member of the Louisiana Music Educators Association.

Persons wishing to submit names of candidates for induction into the LMEA Hall of Fame should send a letter of nomination, along with a biographical sketch, to the chairman of the LMEA Hall of Fame Committee, to be received no later than May 1st. The biographical sketch should include the achievements of the candidate in the criteria listed above. Nominees will not be considered without the biographical sketch. Inductees are selected by the Hall of Fame Committee by secret ballot. The current chairman of the LMEA Hall of Fame Committee is Tom Wafer, 1834 Wimpole Drive, Baton Rouge, Louisiana 70815.

## **Outstanding School Administrator Award**




Awards and presentations will be made annually to outstanding school principals and/or superintendents who demonstrate support for and commitment to high-quality arts education programs in their schools. The influence of such administrators is a major factor in improving music education in school systems across the state. Elementary school principals, secondary school principals and school district superintendents may be selected to receive this award. Individuals holding titles as assistant principal and assistant or associate superintendent also qualify. This award is not intended to honor music supervisors, music coordinators, etc. Administrators receiving awards will be notified by the LMEA Executive Board and a presentation honoring them will take place at the LMEA Annual Conference.

Selection by the LMEA Committee will be based on the following criteria: Nominators must submit the following for each administrator:

- 1. The school or school district under the administrator's supervision must have an exemplary music program, with the majority of the music staff holding LMEA membership.
- 2. The administrator must have served in the administrative position in the same school or district for no less than three years.
- 3. The administrator must be an active advocate for arts education in the school and community.
- 4. A financial commitment to music programs must be demonstrated in the school or school district.
- 5. The administrators must show strong leadership, good school management, and good rapport with teachers, parents, students, and other administrators.
- 6. Music supervisors/coordinators are not eligible for this award.

Nominators must submit the following for each administrator:

- Completed School Administrator nomination Form verified and signed by the nominator.
- 2. Resume of nominated administrator.
- 3. Two letters of support, including one from the music education faculty in the administrator's school district.
- 4. A picture of the administrator suitable for publicity purposes.
- 5. Name and address of the administrator's local newspaper, television and radio station where applicable.
- 6. Additional support materials such as press clippings if available.

He has been named District 2 Band Director of the Year three times, director of the Louisiana All Star Band in 2004, past president of the District 2 BDA Association, and was the recipient of the Louisiana Association of Teacher Educators Outstanding

Clinician award in 2014. Mr. Walker is also an adjunct professor at Louisiana College and has served on the staff of the Macy's Great American Marching Band for nine years. He is a member of Kappa Kappa Psi, Phi Mu Alpha , and Phi Beta Mu.

#### STUDENT ELIGIBLITY - INSTRUMENTAL

- 1. All students must be a member of the band at their school. If there is no band program at the school, students may be submitted by an LMEA member.
- 2. High school students must play a solo from the Texas Prescribed Music List (PML) level one or level two. Middle/Elementary school students must play a solo From the Texas PML level one, two or three.
- 3. Students are eligible for one solo on an instrument.
- 4. All solos with piano accompaniment must be performed with the accompaniment. (Smart music, CD, etc. is acceptable.) (CD, etc. piano part only)
- 5. Memorization is NOT required.
- 6. High School soloists are allotted 8 minutes. Middle school soloists 6 minutes.

#### STUDENT ELIGIBILITY – VOCAL

- 1. All students must be a member of the choir at their school. If there is no choir program at the school, students may be submitted by an LMEA member.
- 2. High school students must sing a solo from the Texas Prescribed Music List (PML) any level. Middle/Elementary school students are not eligible.
- 3. Students are eligible for one solo.
- 4. All solos with piano accompaniment must be performed with the accompaniment. (Smart music, CD, etc. is acceptable.) (CD, etc. piano part only)
- 5. Memorization IS REQUIRED.
- 6. Vocal soloists are allotted 6 minutes.

Please note: LMEA high recommends live accompaniments. A piano will be in each performance site. Students using Smart Music, CDs etc. must provide ALL equipment. Students must set up, perform and take down all equipment in the allotted time. Solos (requiring an accompaniment) performed without accompaniment, for any reason will receive comments only. Performance times will be strictly enforced.
