DISCUSSION Committee met over 100 hours, solicited feedback from directors, and worked through the positive and negative feedback. The rationale – to update the requirements to fit current school music programs – greatest issue ... school size should not be the greatest

determination. Covid modifications made assessment more attainable for groups to be successful. Underserved groups felt they could come to the assessment table.

POINT – Covid modifications have expired.

POINT – 2^{nd} and 3^{rd} groups are sight reading different levels – typo addressed.

POINT – Accessibility and rigor have been achieved.

Sheily Bell – concern with the sight-reading level. Clarification given by Billy Hochkeppel. Band will have a minimum level of sight reading. The piece you play on stage can be as high as you want it to be – the sight-reading component is determined not selected. All details are in the proposal in Google drive.

DISCUSSION: District IV STAGE

- Concerns with directors bringing multiple groups & some being the same voicing
 Needing clarification on what that would look like with levels & correlation to SR
- We do not need to lower the expectations for all.
 - I do like the form which allows schools who are struggling to apply to be scored a level down. That is fair, but to completely dull down the expectations for everyone is not.
- For the middle school classifications, are years of instruction ONLY defined as years of Large Ensemble Assessment experience? (i.e., an 8th grade choir that's been in choir for 3+ years, but this is their first year at Large Ensemble Assessment would qualify as Level 1?)

Sight Reading

- Allowing students to sing along with the piano in SR is not considered SR
 - "I have never known of a sight reading assessment in any level to be able to sing with piano during rehearsal and during performance."
- Need clarity on the levels & what would be required in those levels
 SR rubric will clarify this
- What are the expectations in the sight reading room?

District IV Overall Concerns

District IV vocal directors are frustrated because they were not asked to help on this committee.

I am concerned at the pace in which this is being pursued. I think the best option would be to create a committee to finish defining the new guidelines in this proposal and then enact them next year.

• These guidelines should have feedback from vocal chairs in every district.

• Consider changing the rules for this year for SR and adding the packet for next year. I am strongly pleading that this proposal does not get passed and that more directors are invited to be a part of these changes and the conversation so that we can serve all choral programs in our state, not just a few.

POINT – you can choose to read a level up.

POINT – It would be good for the district directors to be able to get together again so that we can have a unified front.
